Reference: May 27<sup>th</sup>, 2005 Heritage Violation at Cape Henlopen H.S.  
Ladies & Gentlemen,

It has come to our attention that, Mr. Nashon Selby, a teacher at the Cape Henlopen High School, has used defamatory language during assembly of the Junior and Senior Graduating classes, while apparently representing the Policy and Staff of the Cape Henlopen High School and School district.

Mr. Selby took it upon himself to assume, and initiate, a School district dress code policy, telling the Children what they could and could not wear, while making threatening, intimidating, and discriminating remarks, intended for, and initiated against, a minority group of Southern School Children, while at the Cape Henlopen School.

During School Assembly, on May 27<sup>th</sup> 2005, Mr. Selby stated that: " You *Rednecks* will not be wearing the *Confederate Flag* or you will not walk at graduation". Mr. Selby mentioned that " The South lost the War", somehow giving justification to discriminate against Southerners and descendants of Confederate Soldiers.

Let it be known that American Confederate Soldiers were recognized by an Act of US Congress, c.1913, as American Servicemen, affording them all due rights as US Servicemen, including and not limited to Pensions and Veterans Administration Headstones.

As descendants of Southerners, and American Confederate Veterans, we object to the Language and Policy Mr. Selby is using in our Public School system, while representing the Staff and his assumed School district Policy of Cape Henlopen.

We hereby request an investigation into Mr. Selby's integrity as a School Teacher at Cape Henlopen High School and School district.

We request that we are notified of any hearings so that we may be present, and of any actions taken, against Mr. Selby.

We also request that the Cape Henlopen School and School district immediately initiate, and enforce, a policy of Non Discrimination against any American Citizen regardless of their Race, Creed, and -OR- *National Origin*, applicable towards all School Children. -----Over please-----

**We feel what Mr. Selby has done is in Violation of State and Federal Discrimination Policy's, not alone a First Amendment Violation of Free Speech and Expression.**

**If disciplinary action is not taken, we will be forced to refer this as a Heritage Violation, and proceed with remedial actions.**
